S. Navy Corpsman who has trained with Marine FMF units in excess of ninety (90) days and earned the Marine Corps Device or Warfare Device worn on the Service Ribbon authorized for FMF Corpsmen. If discharged, I am in receipt of an honorable discharge or DD-214. By signing below, I hereby agree to provide proof of honorable service/discharge.

Associate memberships are available for those persons who do not meet the above criteria but believe in the Marine Corps ideals. Associates having served in another branch must have a documented Honorable Discharge. Associate members have some limitations as to voting and uniform requirements. Those will be provided in an Associate Member Packet upon completion of the application process.

Membership includes a subscription to the Marine Corps League magazine and the California Leaguer newspaper along with lapel pin. Active duty and reserve Marines receive a 10% discount. There are other benefits and services that are available to members in addition to local events, activities, programs and the camaraderie of other Marines.
